Subject: Cut off Time for Shipping Instruction (SI) and Amendment BL

Dear Valued Customer,

According to the TH Customs regulation and procedure, Notification No. 134/2561 dated 8 May 2018, cargo outbound (Ex Thailand) has to declare manifest to TH customs within 24 hours prior vessel departure from Thailand ports.

To comply with customs regulation. The schedule for submission SI is 72 hours prior vessel departure and amendment by 48 hours prior vessel departure. Please refer to below schedule for your guidance. If failure for SI submission, the customs penalty will be on customer's account.

  - Indonesia / China : Shipper/ Consignee/Notify Party TAX ID and HS Code 6 digits
  - Vietnam : Shipper/ Consignee/ Notify party TAX ID and HS Code 4 digits
  - Malaysia : HS Code 6 digits

Failure to submit VGM via e-commerce within cut off time will be charged \$25/container.
