Subject: Cut off Time for Shipping Instruction (SI) and Amendment BL

Dear Valued Customer,

According to the TH Customs regulation and procedure, Notification No. 134/2561 dated 8 May 2018, revision on 22 August 2019, cargo outbound (Ex Thailand) has to declare manifest to TH customs within 24 hours of vessel actual departure from Thailand ports. To comply with customs regulation. The schedule for submission SI is 72 hours prior vessel departure and amendment by 24 hours prior vessel departure (Except shipment 24hrs Destinations). Please refer to below schedule for your guidance. If failure for SI submission, the customs penalty will be on customer's account.

- 3. Please pick up empty container 24 hrs before CY Closing time.
- 4. Please provide necessary information in Shipping Instruction for below countries:
 - Indonesia / China & Transshipment at China: Shipper/ Consignee/Notify Party TAX ID and HS Code 6 digits

- Vietnam : Shipper/ Consignee/ Notify party TAX ID and HS Code 4 digits

- Malaysia : HS Code 6 digits

- Bangladesh : HS Code 8 digits & BIN/VAT/AIN number for Consignee & Notify Party

- India & Foreign Remaining On Board : HS Code 6 digits & Cargo Value (Invoice Value) for Imp manifest only
- 5. Please submit VGM via e-commerce URL: https://th.one-line.com/ (User Name/Secured Password are mandatory to access the website) Failure to submit VGM via e-commerce within cut off time will be charged \$30/container.
- 6. Respecting to FROB regulation towards USA/CANADA delivery under NVOCC (Foreign Cargo Remaining On Board/FROB)
 - PN2 service will call Tacoma, USA before Vancouver, CA. If the shipment destined POD/DEL in Canada. The shipment FROB's over Tacoma, USA. Both AMS and ACI must be submitted.
 - EC5 Service will call Halifax, CA before New York, Savannah, Jacksonville & Norfolk, USA. If cargo destined to POD/DEL in USA and the shipment FROB's over Halifax, CA. Both AMS and ACI must be submitted.
 - -PS3, EC4 are direct call service to USA. FROB will be no require.
