## Revision in Demurrage & Detention Calculation Logic

Dear Valued Customer,

Thank you for your continued support and for choosing Ocean Network Express (ONE) to cater to your needs.

Please be kindly advised that ONE will revise the Demurrage & Detention Calculation logic to be a jump tariff after f/t expiry for all type size. The new calculation will be applicable from/to Thailand across all trade lanes and services and will be valid till further notice. Kindly refer the example of calculation.

**Remark:-**

**Example A**, normal tariff is applicable (5 working days) while 2 days over the normal tariff. The calculation will be 1st Tier x 2 days

**\*Example B**, we provide 7 Days Calendar Day but 9 days total usage. The calculation will be 1st Tier x 1 day (System logic will trigger the normal f/t (5 working days) at first tough point, then calculate the excessive day, this case will be billable 1st tier x 1 day & discount 1 day)

**Example C**, we provide 10 Days Calendar Day but 14 days total usage. 1st Tier x 3 days + 2nd Tier x 1

**Example D**, we provide 14 Days Calendar Day but 17 days total usage. The calculation will be 2nd Tier x 3 days

**Example E**, we provide 21 Days Calendar Day but 23 days total usage. The calculation will be 2nd tier x 1 day + 3rd Tier x 1 day

\*Reduce Tier 2 number of applicable dates from 10 days to 6 days (Day 5-14 to Day 5-10) for Thailand export. By doing this, tier 3 will be implemented from Day 11 onwards both demurrage & detention tariff.

\*\*Tier 3 setup for RF export (THB 2800/3600 per R2/R5) fro Day 11 onwards both demurrage & detention tariff.

\*\*\* For any Dangerous Goods outbound from Thailand, The storage at JWD is subjected to JWD's tariff and JWD storage charge shall be for the account of cargo.

:- There will be no detention free day towards cancellation shipment. 1st tier of detention tariff will be implemented since empty container pulling out from our depots until empty return.
