Revision in Demurrage & Detention Basic Free Time (Import)

Dear Valued Customer,

Thank you for your continued support and for choosing Ocean Network Express (ONE) to cater to your needs.

Please be kindly advised that ONE will revise the basic free time tariff for inbound shipment from working days to be calendar days. Tier, Quantum & logic of jump tariff applicable remain unchanged. The new basic free time will be implemented to inbound to Thailand across all trade lanes and services and will be valid till further notice.

Example c, 23 days are total equipment utilization vs 21 calendar days given free time. The billable amount will be based on 3rd tier x 2 days
