**POR at BBT, LKR, LCH:** Cancelled booking is done by WED (before 17:00 pm) or before, there will be no charge of CCL. Cut-off is subject to change based on CY Cargo cut-off in each POR.

For DG Cargo, Booking Cancellation Fee (CCL) will apply once Booking Receipt Notice confirmed to the customer.
Only cancelled/postponed bookings will be charged booking cancellation fee (CCL). In case of volume reduction, CCL won't be applicable but will be imposed the change of booking status fee (CBS)
Aforesaid tariff/quantum will be implemented to CY status only.
